Harris School Solutions has an issue tracking system, named JIRA, to monitor program enhancements and defects. You are able to reference these issue numbers through Team Support. The WEB numbers refer to the issues in JIRA that were resolved in this release.

New Features

TSDS/PEIMS: Added new features and made multiple changes to existing features to meet requirements for the Fall & Summer extracts & RF Tracker.

Admin

 - Calendar: Moved the Calendar editor to the Annual Information tab. It functions in the same way as when it was on a separate tab. WEB-2340
 - Extended Learning Opportunities: Added a screen to enter ELOs for instructional periods beginning with the 2019-2020 school year. WEB-2339
- District > Districts > Districts > Annual Information: Added a multi-select list called Gifted Talented Program to designated gifted & talented programs offered in the district. WEB-2543

- Students > Special Ed > Surrogates: This new screen allows you to create surrogate records containing the surrogate's name, address, phone, and email. WEB-2335
- Student Manager
 - Special Ed
 - Restructured the screens in the Special Education editor, adding tabs for Disabilities, Services, ARD History, and IEP History. WEB-2327-2332
 - Residential Facility Residency History: Use this screen to enter a residency facility and entry date for use in the RF Tracker, WEB-2336
 - Surrogates: This screen allows you to add surrogates to a student's residential facility record. Surrogates are only used in the RF Tracker. WEB-2334
 - Effective dates: Added the Effective Date field to the main Special Ed screen and the Disabilities and Services tabs. These dates are to be reported in the StudentSpecialEdProgramAssociationExtension. WEB-2094
 - Programs/Statuses
 - Economic Disadvantage: Added the Student-Census-Block-Group to this screen. WEB-2150
 - Other Program Info: Added the Dyslexia Risk Code. WEB-2465 Updated the wording of LEP (Limited English proficient) to EL (English Learner). WEB-2099

- Commodity Report: Lists all configured commodity categories and their assigned vendors. It includes commodity category code & description; vendor name, number, address, city, state, postal code, & country; and whether or not it's been utilized. WEB-2575
- Requisition Status: This new report can be run for outstanding requisitions with filters to include unsubmitted, under review, rejected, approved, and receiving. The report lists the PO number, requestor, description, vendor, transaction & accounting dates, status, total amount, and amount received. The number of signatures remaining and the name of the next signatory are included for requisitions that are under review. WEB-1223
- Reimbursement Status: This new report can be run for outstanding reimbursements with filters to include unsubmitted, under review, rejected, and pending. The report lists the PO number, requestor, description, vendor, transaction & accounting dates, status, requested, adjusted, & total amounts, and comments. The number of signatures remaining and the name of the next signatory are included for reimbursements that are under review. WEB-2499
- **Purchasing & AP > Vendors > Commodities**: Allows users to create, update, and delete commodity categories, which are used to group commodity item codes. Commodity categories can then be linked to particular vendors to limit the available number of codes on any given data entry screen. WEB-2238, WEB-2237
 - IMPORTANT NOTE: Commodity categories are NOT available for use in POs and requisitions and won't be included in reports — with this release. Those features will be available in a future release. This release will allow you to start setting up your vendors to use commodity categories.
